<b>2.</b>	<b>Promoter’s details:</b>	<p>This Competition is conducted and organized by Kwena Square Mall (“<b>Mall</b>”), offered by Redefine Properties Limited (Registration Number: 1999/018591/06) (“<b>Landlord</b>”) and sponsored by Decathlon (Registration Number: 2015/118486/07) and Bidvest Waltons (Registration Number: 1997/010942/07) (“<b>Tenant</b>”).</p> <p>In these T’s &amp; C’s, we refer to the above promoter(s) as “the Landlord” and the entrants as “the Participant(s)” or “you.”</p>

<b>3.</b>	<b><u>Eligibility:</u> Who may enter the Competition?”</b>	To enter the Competition a participant must be 18 years and older and in possession of a valid South African identity document or passport with a valid temporary or permanent residence permit for South Africa (“ <b>Participant</b> ”). No Minors are allowed to enter the Competition.
<b>4.</b>	<b>Who cannot enter the Competition?</b>	The Competition may not be entered into by any director, member, partner, employee, agent, consultant, tenant of the Landlord at the Mall, the marketing service providers and/or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners or immediate family members.

The displays will be in front of Checkers from 22 November to 20 December 2024;</p> <p>iii. Customers from Kwena Square will use the QR codes allocated to each tree and/or wreath to vote for their Favourite ;</p> <p>iv. and submit their Entry (“Entry”).</p> <p>The top 3 (three) schools with the most votes will win prizes proudly sponsored by Bidvest Waltons or Decathlon.</p> <p><b>Customers may only cast one vote for one school only.</b></p>
<b>7.</b>	<b>Limitation on entries</b>	A Participant may enter only once during the Competition Period.
<b>8.</b>	<b>How will the Winner/s be selected?</b>	The QR Code voting system will determine which top 3 schools have received the most votes.
<b>9.</b>	<b>Winner announced on</b>	The Winning Schools for the Competition will be selected on Monday, <b>23 December 2024.</b>
<b>10.</b>	<b>The prizes</b>	<p>The 3 (Three) Winning schools of the Competition shall receive sponsored prizes (prize number one, two, and three from Decathlon and Waltons. Wherein the value of the prizes will not be same.</p> <p><b>None of the Prize is transferable and will not be changed, deferred, or exchanged for cash for any reason whatsoever. Prizes are only valid for the duration of the prize on each voucher. Prizes are at the discretion of the Sponsor.</b></p>
